This Privacy Policy has been crafted to better serve those who are concerned about how their "Personal Data" (PD) is used online.

PD means any information relating to an identified individual ("data subject"); an identifiable individual is a person who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier, or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural, or social identity of that individual.

What personal information do we collect from people who visit our website?

When ordering services through the website, in relevant cases, you may be asked to provide: last name, first name, patronymic, passport series and number, issuing authority, date of issue, expiration date, email address, phone, or other details necessary to assist you in obtaining services.

When do we collect information?

The processing of the personal data provided by you is carried out for the period necessary for the processing of the order, provision, and implementation of the corresponding service to you, as well as for the period required for the submission of relevant information to regulatory authorities, resolution of legal disputes, or in other cases defined by law.

How do we use your information?

We may use the information we receive from you when you place an order for our services, subscribe to our newsletter, participate in surveys, leave feedback on the services provided, browse the website, or use certain other site features, to:

- Confirm orders;
- Manage loyalty programs, promotions, and special offers;

How do we protect your information?

We have implemented necessary technical and organizational measures to ensure appropriate protection for your personal data. Your personal data is stored in secure networks, and access to it is limited to a restricted number of individuals who have special access rights to such systems and must maintain the confidentiality of the information. We implement various security measures when a user places an order, enters, submits, or accesses his information to ensure the security of his personal data.

How long do we retain your personal data?

The retention period of personal data depends on the legal basis for their processing. If you wish to know how long we retain your personal data, please refer to your rights outlined below. Upon request for access to your personal data, we will provide you with such information.

The legal basis for processing your personal data is the presence of one of the following grounds:

Performance of a contract: Processing your personal data is necessary for the performance of our obligations under the contract or for the initiation of a contract based on your request.

Compliance with a legal obligation: Providing information to governmental or law enforcement authorities as required by law.

Legitimate business interests: We have the right to process your personal data if such processing falls within the scope of our legitimate interests and is necessary for our lawful activities, provided that such processing does not violate your rights, freedoms, and interests.

In the absence of one of the above-mentioned grounds, we seek your consent to process personal data. You have the right to withdraw your consent at any time by contacting us at: support@meest.cn.

What rights do you have?

- You have the right to request correction or updating of personal data;
- You have the right to restrict our right to process your personal data (under certain circumstances);
- You have the right to withdraw consent for the processing of personal data at any time;
- You have the right to prohibit the processing of your personal data (under certain circumstances).
- You have the right to request access to your personal data from us;
- You have the right to file a complaint with the supervisory authority.

Do we use "cookies"?

Yes. Cookies are small files that a website or its service provider transfers to your computer's hard drive through your web browser (if you allow it), enabling the site's systems or service providers to recognize your browser and capture and remember certain information.

We use cookies for various reasons listed below.





Unfortunately, in most cases, there are no industry standard options for disabling cookies without completely disabling the functionality and features they add to this site.
