# TRACK NUMBER REGISTRATION IN THE MEEEST CHINA APPLICATION

**THE TRACKING NUMBER** is a unique code for your parcel that was sent to China. Thanks to it, warehouse staff can identify the goods and add them to the corresponding client's account.

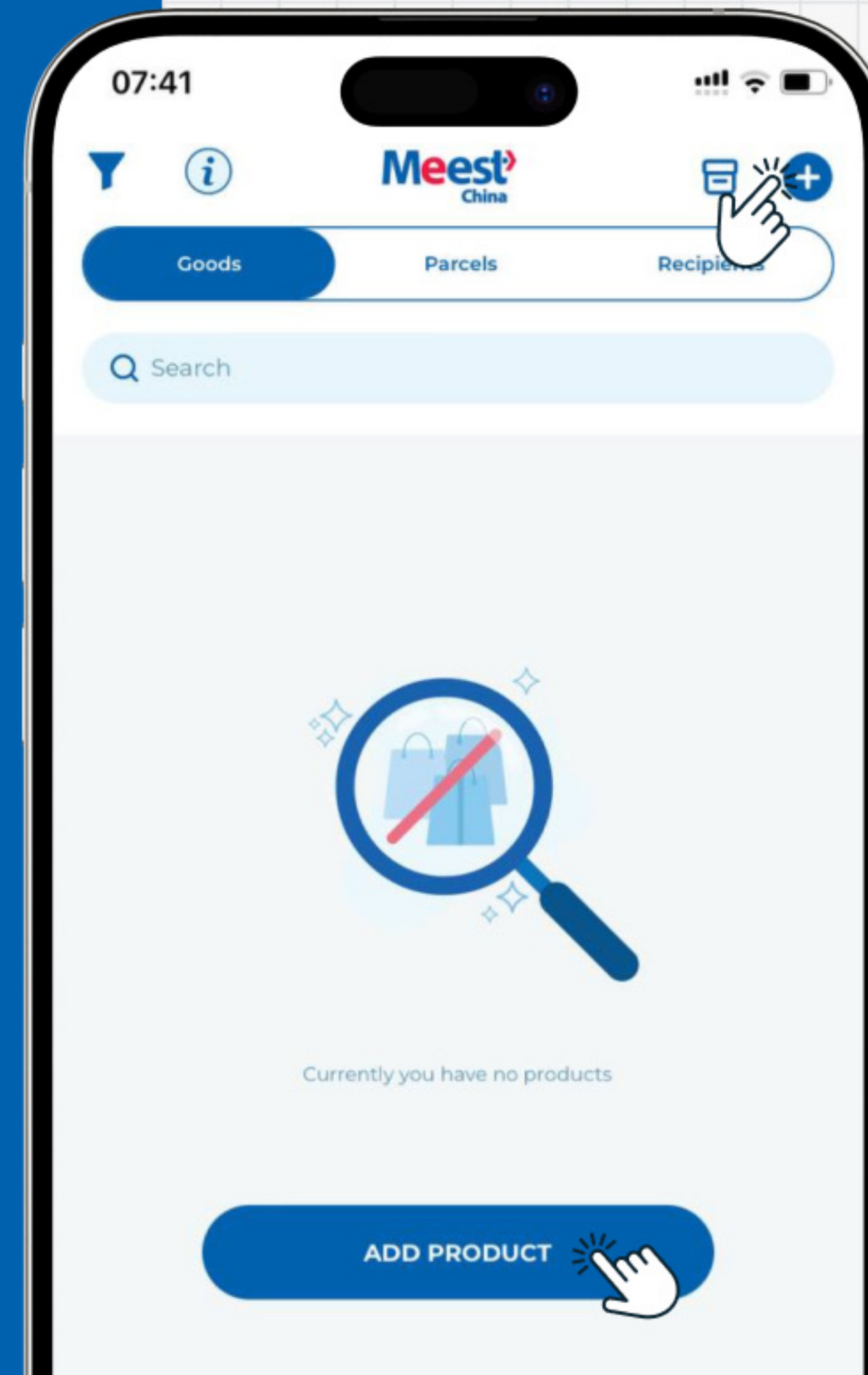
If the track number registration is not completed, the goods are received at the warehouse and added to your account as unidentified. After that, you need to remember which goods you ordered before, and when there are several goods, this slows down the identification and delivery of parcels.



# TRACK NUMBER REGISTRATION IN THE MEEEST CHINA APPLICATION

To register the track number in the application, follow these steps:

- ➔ On the main page of the application, go to the "**Goods**" tab and click on the plus sign to add a product 



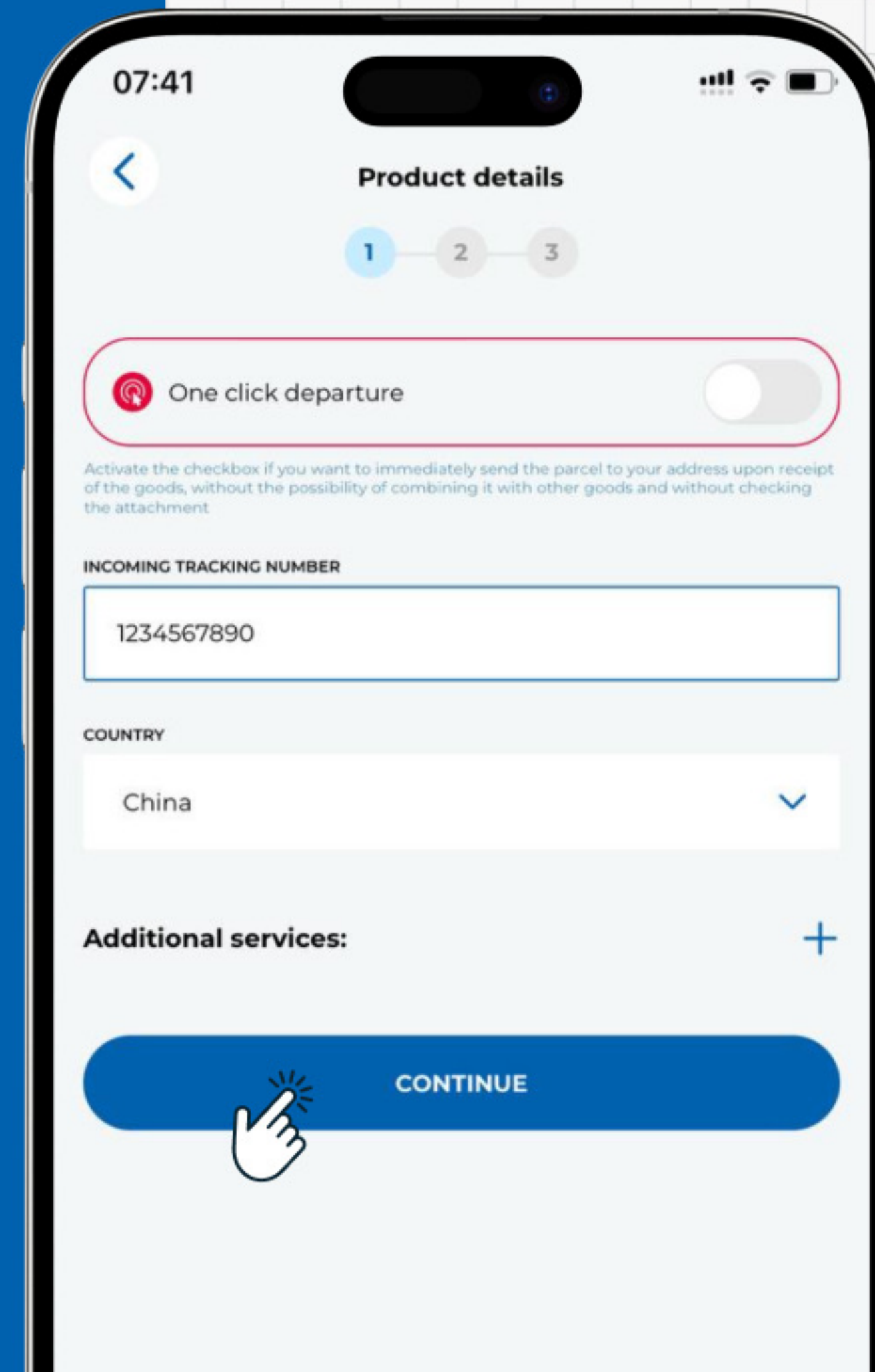
# TRACK NUMBER REGISTRATION IN THE MEEEST CHINA APPLICATION

➔ If you wish to immediately send the goods from the warehouse upon arrival without combining them with other goods at the warehouse, select **"One-click shipping"**.

➔ Fill in the tracking number in the **"Tracking number"** field.

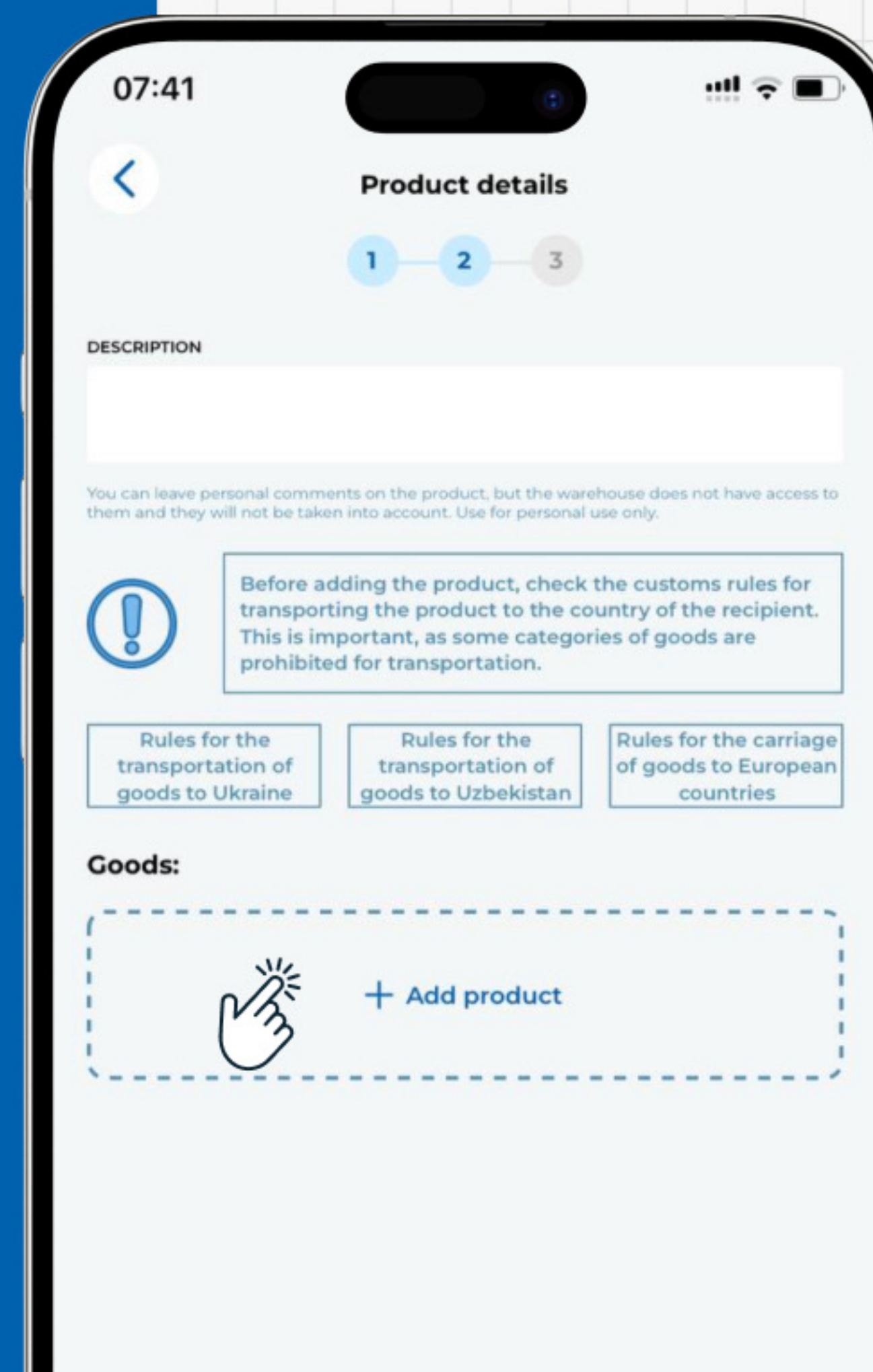
➔ Select the necessary additional warehouse services and click **"Continue"**.

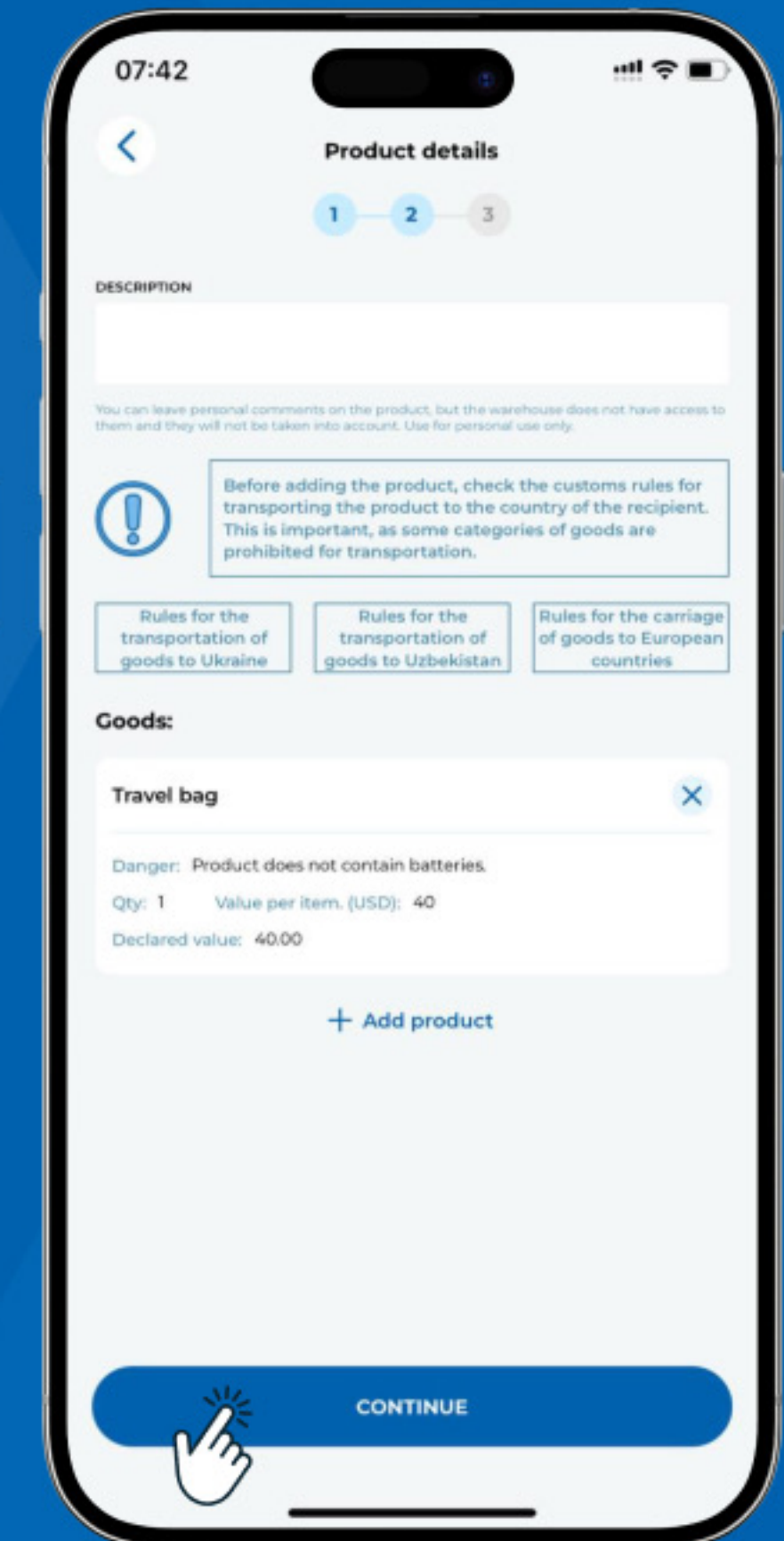
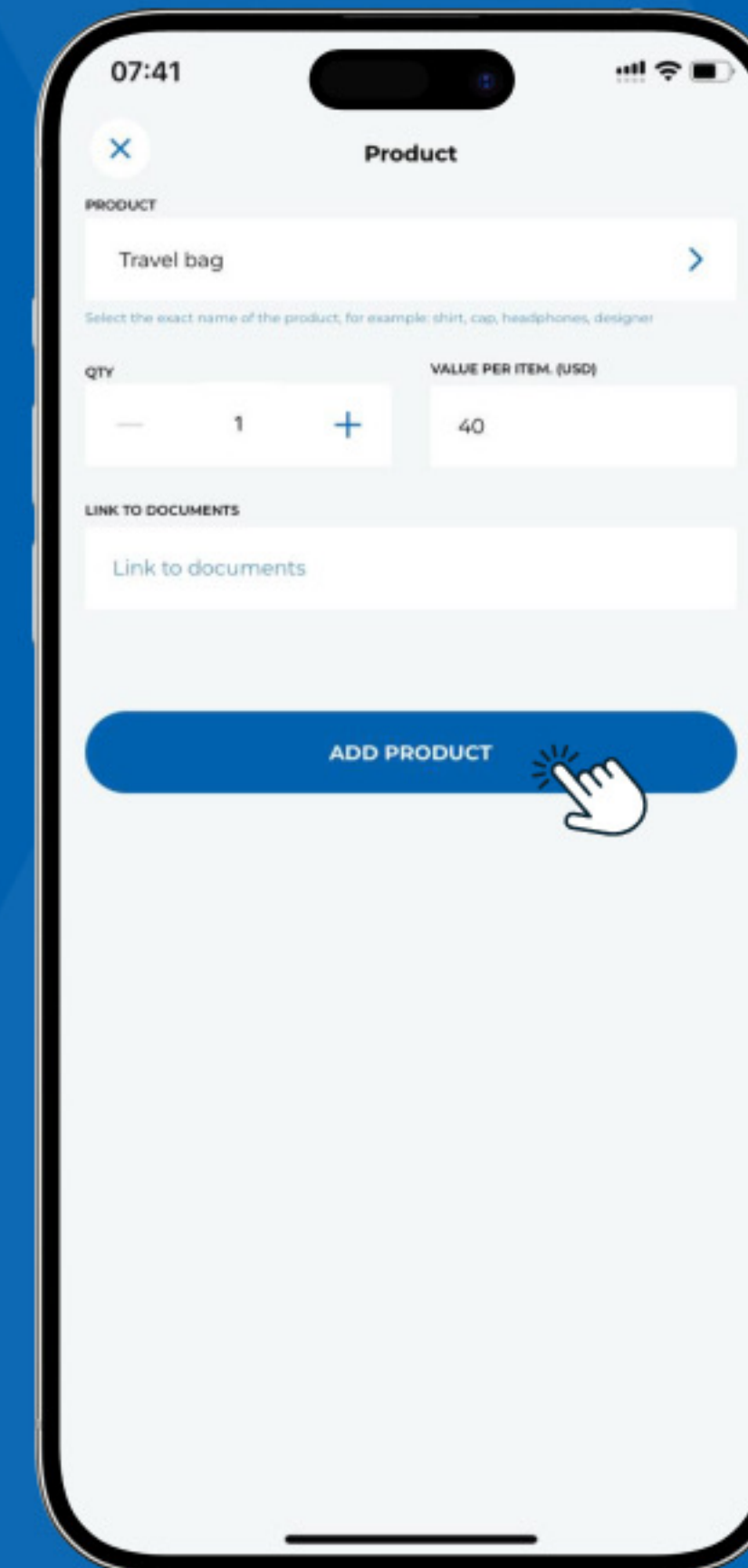

- ➔ Familiarize yourself with the customs rules for transporting goods.
- ➔ **Add the product** to the track number.

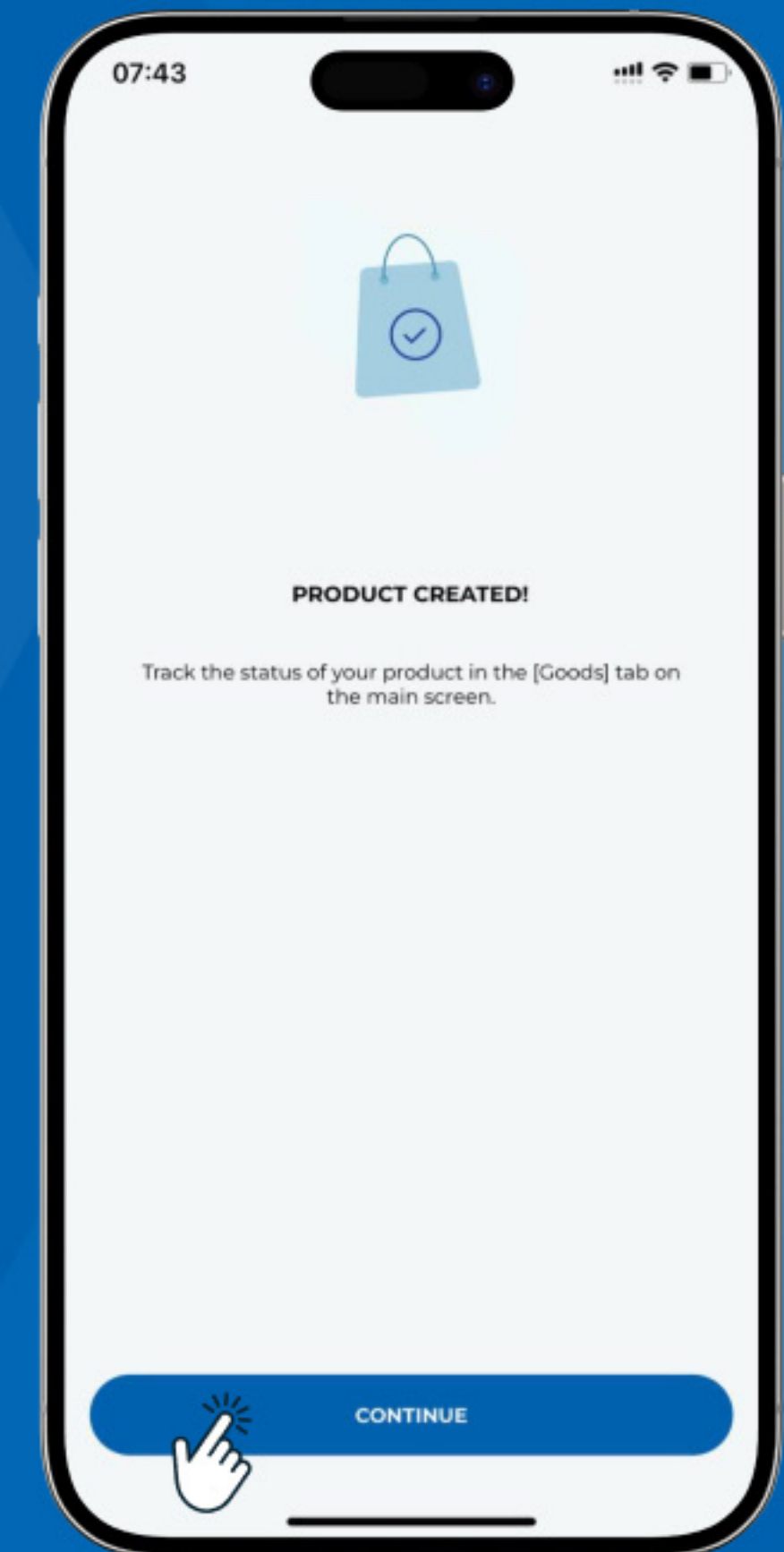
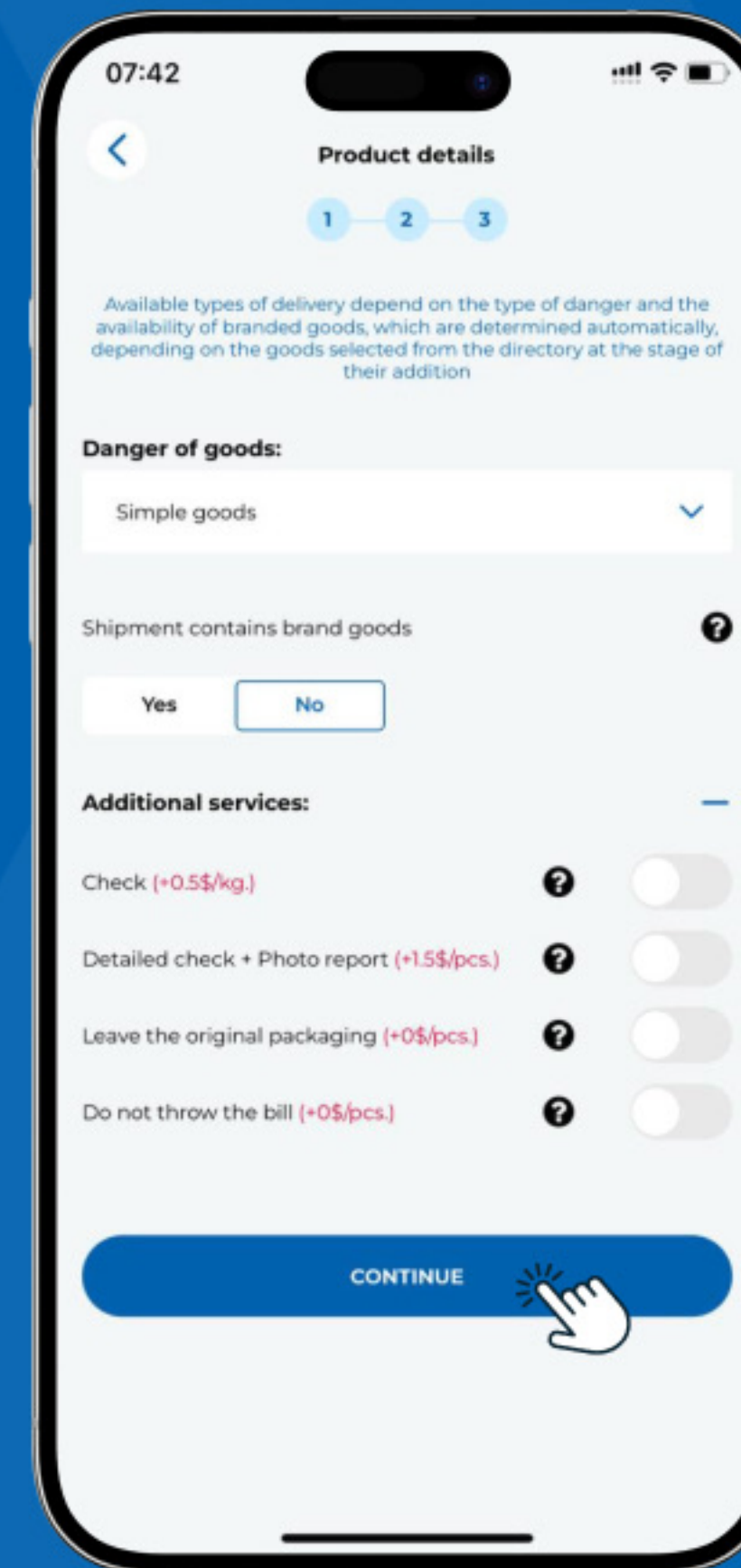
- Specify the exact name of the product according to the catalog.
- Specify the quantity and unit price, then click **"Add product"**.
- If your track number contains multiple items, you can add them by clicking on the plus sign.
- Once all items are added, click **"Continue"**.



# TRACK NUMBER REGISTRATION IN THE MEEEST CHINA APPLICATION

- ➔ Indicate the danger level of the goods.
- ➔ Specify if the package contains branded goods (Click "Yes" or "No")
- ➔ Select additional warehouse services if necessary.
- ➔ Click "Continue".

**Congratulations,** your track number is registered! When the order arrives at the warehouse, you will be able to prepare the parcel for shipment to the recipient's country.

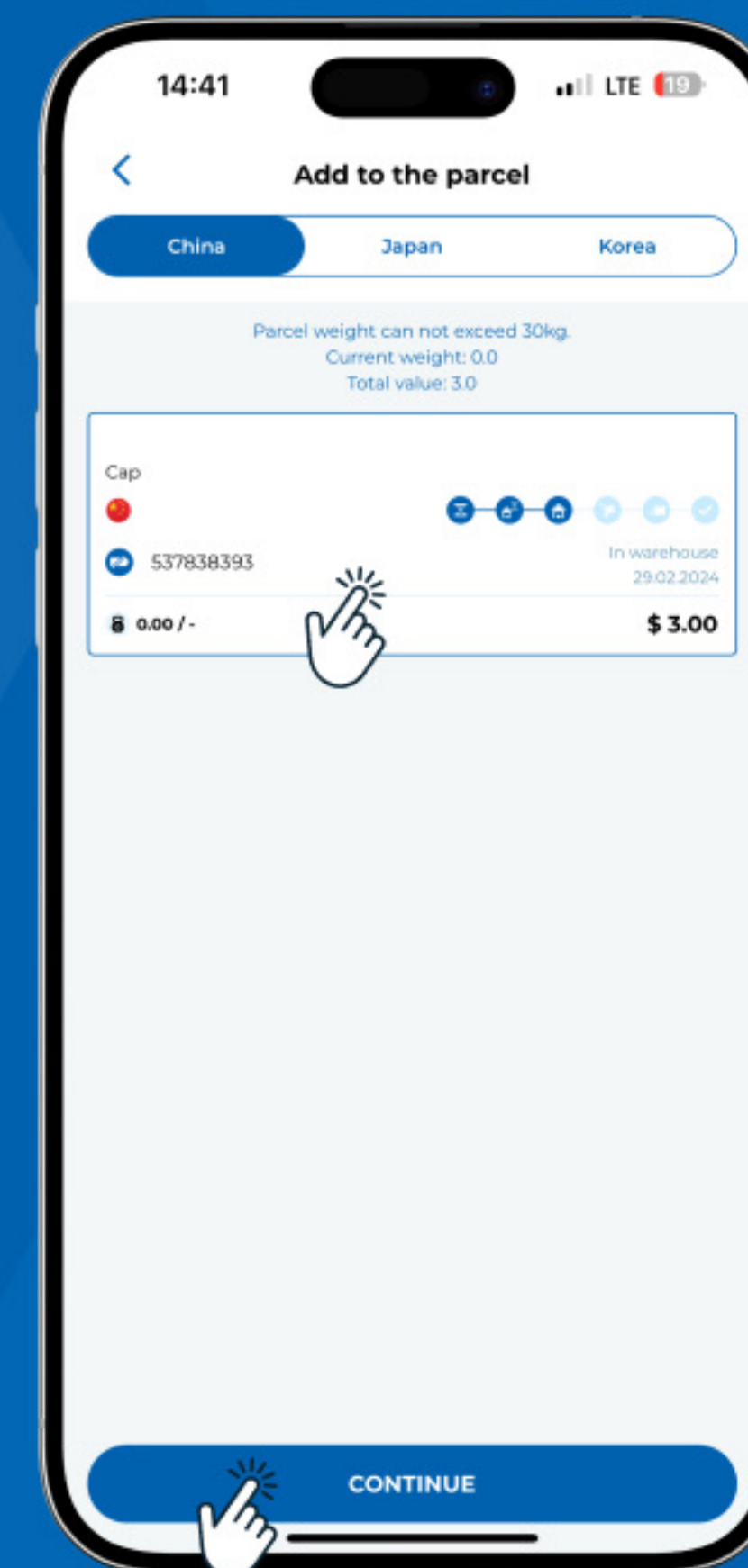
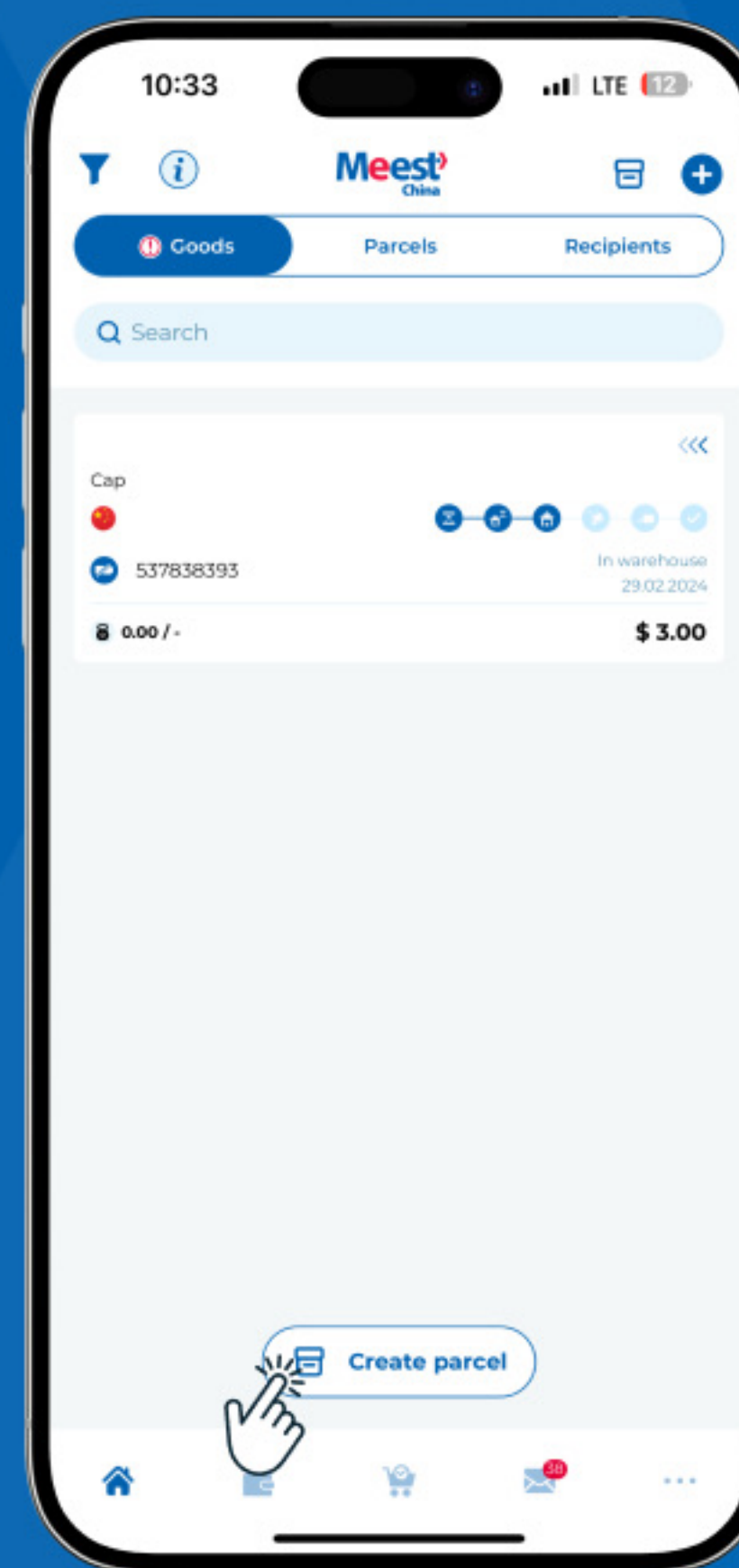

➔ In the parcel payment window, choose the IPS payment system.

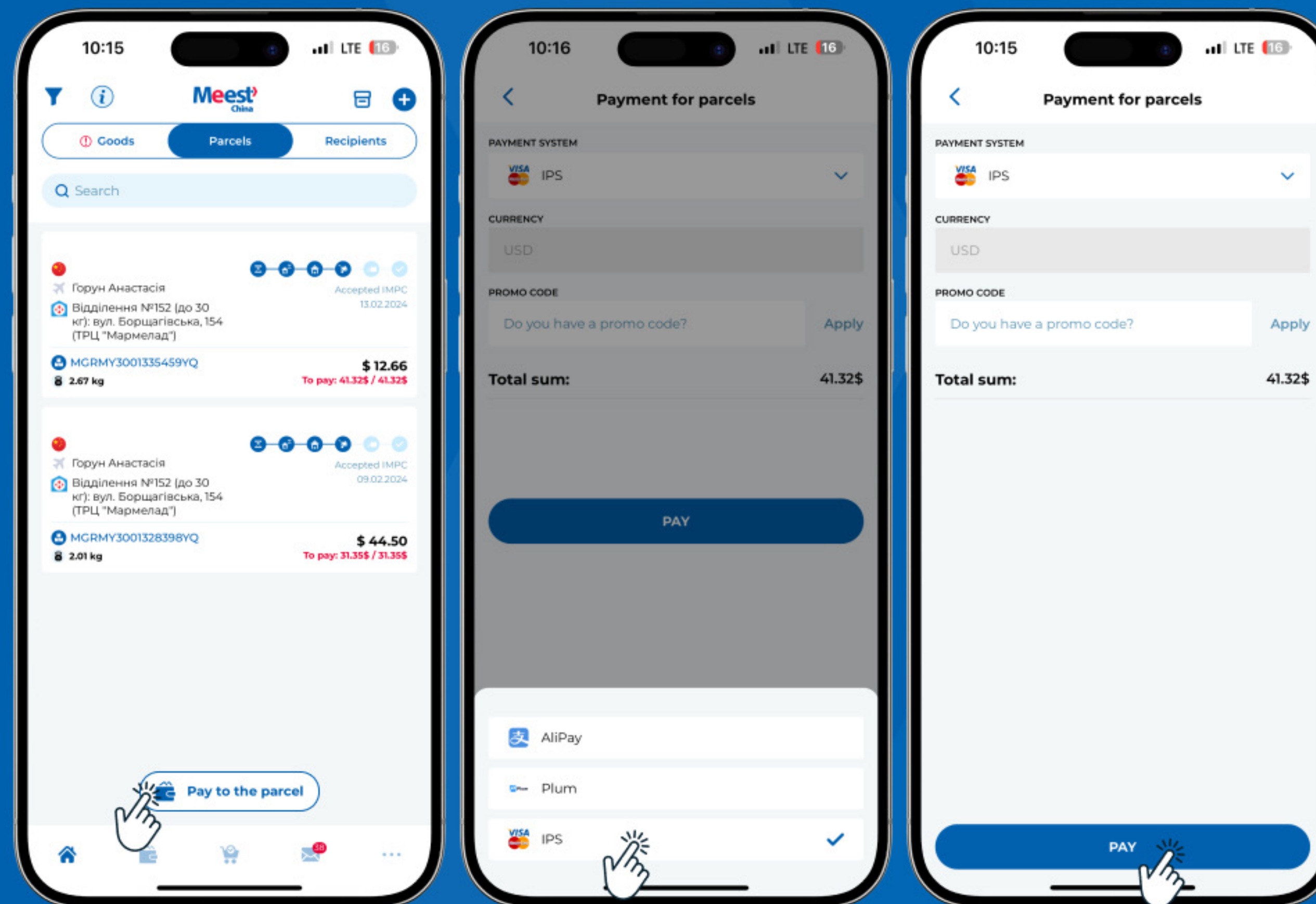
➔ If you have a promo code, enter it and apply it.

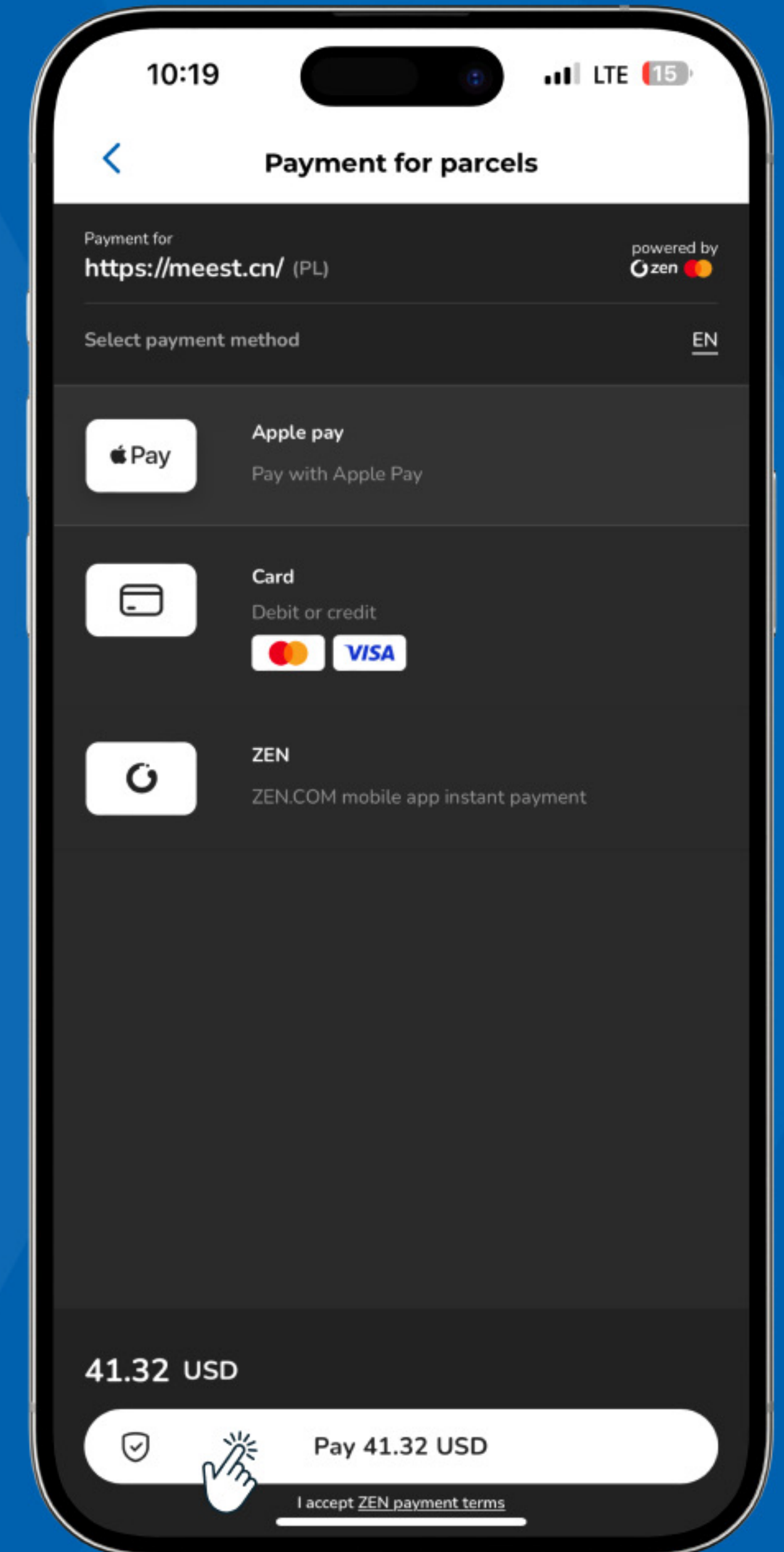
# PAYMENT FOR THE PARCEL
